LIXIL-Haier Housing Products (Qingdao)Opens New Kitchen Plant

TOKYO, Japan: LIXIL-Haier Housing Products (Qingdao) Co., Ltd. (hereinafter LIXIL-Haier), a joint venture between LIXIL Corporation and the Haier Group, has completed construction of a new manufacturing facility in Qingdao, China, holding an opening ceremony on June 7, 2013. The new plant will serve as a central production base for LIXIL-Haier's modular kitchens and kitchen components.

Since its launch on December 31, 2011, LIXIL-Haier has been manufacturing products, primarily modular kitchens, for the rapidly growing Chinese market and selling them through Haier's nationwide distribution channels. In its first year of operation in 2012, it made and sold some 90,000 modular kitchen units.

The new Qingdao plant will help expand LIXIL-Haier's offerings, manufacturing not only kitchen cabinets but also an array of components used for modular kitchens, including finished doors and artificial marble countertops, and aims to generate stronger domestic sales of kitchen appliances and related products.

LIXIL Corp. owns 51% of LIXIL-Haier, while the Haier Group holds the remaining shares. The joint venture is capitalized at CNY 194 million and employs 1,112 workers.
