Kinya Seto Appointed Leadership Roles at LIXIL Corporation

Tokyo – LIXIL Group Corporation ("LIXIL Group", TSE Code: 5938), maker of pioneering water and housing products, today announced that the following personnel changes have been made to the Board of Directors of LIXIL Corporation, a major subsidiary of LIXIL Group.

Kinya Seto, who assumed office as Director, Representative Executive Officer, President and CEO of LIXIL Group following the 77th Annual General Meeting of Shareholders and the meeting of Board of Directors held on June 25, has been concurrently appointed as Representative Director, Chairman, and Chairperson of the Board of LIXIL Corporation. Taking on these new roles, he will closely work with Kazuhiko Ootsubo, who serves as Representative Director, President and CEO of LIXIL Corporation, and other executive team members and focus on promoting Group-wide initiatives such as strengthening corporate governance and enhancing operational efficiency in its most strategic market, Japan.

In addition, Yutaka Nakamura, who joined LIXIL in June 2018 and served as Director, Senior Managing Director and Chief Legal Officer (CLO) of LIXIL Corporation, has decided to leave the company for personal reasons, effective July 3, 2019. Nakamura has also resigned from his other executive positions including LIXIL Group's Executive Officer and CLO. To ensure business continuity, Sachio Matsumoto, Director, Executive Vice President and Chief Financial Officer of LIXIL Corporation, will serve as acting CLO until Nakamura's successor is identified by the company.
